Chairmans Message

The fall meeting of the Minnesota Repeater Council will be one of the most important in a long time. We will be voting on a fundamental change in the way we do coordination in Minnesota.

You've seen the proposed policy. The reasoning behind it is simple: a repeater should not be protected for any more than the area it actually serves. Once upon a time, it didn't make a lot of difference. Now, it does, and the FCC has served notice that they think the old methods of coordination won't cut it any more.

There was a lot of discussion of the new policy at the spring meeting. More than a few folks were willing to give it a fair hearing. I wasn't surprised to hear negative comments from some folks who don't see the problems with the current policy, or don't think the FCC is serious, or want to have a say in what repeaters serve an area they themselves don't serve.

At the meeting, we asked for comments from the membership on the policy, especially specific suggestions for changes that would answer the concerns that were raised. A couple of minor changes were suggested, and a couple of areas we missed were pointed out. Those suggestions will have been incorporated into the final policy that will be voted on at the meeting.

Coordination Committee Update

At the Spring meeting the MRC Committee on Coordination Modernization presented a proposed new coordination policy following some suggestions made by the FCC about better spectrum utilization and the best practices from amateur as well as commercial repeater coordination. After the presentation the committee chair answered questions from the membership about how this proposed change would affect repeater coordination in Minnesota. At the request of membership present the proposed policy was also made available on the MRC website and an email address was setup to receive comments during a 90 day comment period.

Overall there have been few comments about the proposed policy and those comments which were received were requests for minor changes and tweaks based on previously adopted coordination policies. I have asked the coordination committee to again read through the proposed policy and suggest any changes they see as relevant based on this feedback and other interactions and conversations with MRC members. We plan to distribute the most up to date version of the proposed new coordination policy at the Fall 2009 meeting and recommend that it be adopted as policy.

There have been many changes and advancements in technology and tools available to amateur operators since our current policy was written in 1976. Based on the most recent discussions with the FCC it is our belief that if we do not want the type of rules and regulations currently applied to commercial repeaters to become the rules and regulations for the operation of amateur repeaters we need to heed the advice of the FCC, echoed by Jay in last year's Fall newsletter, and update our coordination policy for the times and technologies now available.

If the proposed policy is adopted by the membership at the Fall meeting one of the most important and immediate changes for repeater owners will be to make sure that they have supplied full and accurate repeater information to the Coordinator as this information will be used to determine whether proposed repeaters may be coordinated or not. Failure to report accurate information not only harms the coordination and modeling process but is specifically listed as grounds for revocation of coordination. I've already begun the process of double checking all of my repeater information and correcting errors and I would encourage you to do the same.

I would also like to thank Lion Templin (KB9ENE) who has done the majority of the work in translating the discussions and decisions at committee meetings into the policy seen at the Spring meeting and who was mistakenly omitted from the list of committee members in the Spring 2009 newsletter.

Secretary, Treasurers & Coordinators Notes

In mid August the annual update forms where mailed out. As they come back I have been entering them into CTK in preparation for submission to the ARRL repeater directory.

Many of the records still have not been updated with accurate or missing data such as location data down to the seconds, true antenna height or power. If we adopt the coordination policy that is on the table, some of you will not be happy with the results.

Several pairs in rural Minnesota have been returned. Several systems moved without re-coordination resulting in additional activity. One example is the 147.000 Blue Earth repeater moved placing it 96.6 miles to the Maple Plain co-channel repeater. As trustee of this system I have worked to model coverage of both systems. Both groups based on this data have started a close space agreement. Under the proposed policy this spacing would meet the -100db criteria.

You may update your records or repeater at any time you do not need to wait for the form to arrive in the fall. The idea of lets move our repeater and worry about coordination later does not fly when I get a update form with most of the data with whiteout on it with new a new location and parameters on it. A new coordination form is generated at that point.

Midcountry Bank where our checking account resides changed their account number scheme last year expecting to silently update everyone as they ordered new checks. We do not write enough checks to use up the supply on hand. As a result we have a gap in check numbers as indicated in the treasurers report.

When you send checks for dues, please include a membership application with the required information marked. This serves as a backup paper copy for my records and shows what the payment is for!

Our ARRL license agreement for the repeater directory was not received or lost by the ARRL, as such we did not receive payment for the 2008/2009 data. The 2009/2010 agreement has been completed and mailed in and an acknowledgement received back. There was also a report that some older data may have been in the Repeater Directory this year.

Contacting the MRC Secretary & Coordinator!

I have a full time job, so if you wish to contact me by phone, it is best to try 6-9PM in the evenings except Wednesdays.

Sending registered mail is going to delay my receiving the correspondence, this also requires my leaving work early or going to the post office on a Saturday morning.

I normally read and respond to email on a daily basis, this is preferred if I need to research something or for simple questions.

Repeater updates and frequency applications must be mailed or faxed. I will provide my FAX number upon request. You may also scan your documents and email the document.

You may use email to notify us of operational changes to your repeater like its now on the air or will be off the air for a period of time.

Proxy forms can be mailed or faxed, emailed scans are acceptable, however just a proxy statement is not..

I will continue to ask that you do the following before the meeting. It is much easier to resolve any issues in advance than at a meeting. I can spend more time to help come to a solution.

Check your envelope for your membership status. If you need to pay dues, please fill out the membership form before bringing funds to the table. Or mail the application in advance!

If you look at the envelope this newsletter came in, you will find your expiration date. This is the year you are paid to the end of the listed year. So 2009 is paid up till Dec 31, 2009
